- 19.7 million miles of service
- 725+ buses: electric, hybrid, compressed natural gas, ski buses, coaches, paratransit, and trolley
- 86+ bus routes serving approximately 5,388 bus stops
- Entire fleet is accessible and complies with the Americans with Disabilities Act
- Paratransit operates during the same hours and service area as regular bus and TRAX service

- UTA operates 2 light rail services
- **TRAX** has 114 trains that serve three lines
  - Blue Line from Draper to Downtown Salt Lake City
  - Red Line from South Jordan to University of Utah
  - Green Line from West Valley City to the Salt Lake City International Airport
- **S-Line** is UTA's first modern streetcar
  - 2 miles of service between South Salt Lake and the Sugar House area
  - 100% renewable energy

- 83 miles of service between Ogden and Provo
- Diesel-electric locomotives
- Top speed of 79 mph
- Fully ADA accessible
- Distance-based fare

 **FUTURE PROJECTS**

- **Midvalley Express (MVX):** 7-mile BRT route serving Murray, Taylorsville, and West Valley City
- **Davis-Salt Lake City Connector:** New BRT route connecting southern Davis County to northern Salt Lake County
- **Fare collection:** Update fare collection hardware, including ticket vending machines, card validators, and hand-held fare inspection devices
- **TRAX Forward:** Modernize TRAX with expanded service, upgraded vehicles, station improvements, and more
